3. RULE OF RESERVATION:

A. Vertical Reservation: 69% of the Communal reservation will be followed vertically as per existing Government Rules / Orders i.e.,18% shall be reserved for Scheduled Castes including 3% reserved to SCA on preferential basis amongst the Scheduled Castes, 1% for Scheduled Tribes, 26.5% for Backward Classes (other than Backward Class Muslims), 3.5% for the Backward Class Muslims, 20% for Most Backward Classes and Denotified Communities and 31% shall be filled by open competition.

Provided that even after filling up of the required candidates for posts for SCA amongst the Scheduled Castes, if more number of qualified SCA candidates are available, such excess number of candidates of SCA shall be entitled to compete with the other Scheduled Castes in the inter-semerit among them and if any appointment or post reserved for SCA remains unfilled for want of adequate number of qualified candidates, it shall be filled up by Scheduled Castes other than SCA.

B. Horizontal Reservation:

(i) Women Reservation:

30% of the Women reservation will be provided horizontally as per Tamil Nadu Government Servant (Conditions of Service) Act 2016, section 26, rule (Tamil Nadu Act No.14 of 2016), and existing Government Rules / Orders. If qualified and suitable women candidates are not available for the vacancies reserved for them, those selection against vacancies will be filled by male candidates belonging to those respective communal categories.

(ii) Reservation for Persons Studied in Tamil Medium (PSTM):

As per G.O.(Ms.)No.82, Human Resource Management (S) Department, Dated 16.08.2021.

- a) As per Section 2(d) of the Tamil Nadu Appointment on preferential basis in the services under the State of Persons Studied in Tamil Medium Act, 2010, as amended by Act 35 of 2020, Person studied in Tamil medium means a person who has studied through Tamil medium of instruction upto the educational qualification prescribed for direct recruitment in the rules or regulations or orders applicable to any appointment in the services under the State.
- b) Candidates claiming to be Persons studied in Tamil Medium (PSTM) must upload / produce evidence for the same in the form of SSLC, HSC, Transfer Certificate, Provisional Certificate, Degree Certificate, Mark Sheets, Certificate from the Board or University or from the Institution, as the case may be, with evidence that he/she had studied the entire duration of the respective course(s) through Tamil Medium of instruction at the time of submission of online application.
- c) Candidates must upload documents as evidence of having studied in the Tamil medium, all educational qualification upto the educational qualification prescribed at the time of submission of online application.

Example:

If the prescribed educational qualification is Under Graduate Degree, then the candidate should have studied from the First Standard to SSLC, Higher Secondary Course, Under Graduate Degree and B.Ed Degree (or) First Standard to SSLC, Higher Secondary Course / Diploma Course, Under Graduate Degree and B.Ed Degree through Tamil Medium of instruction.

d) If no such document as evidence for 'PSTM' is available, a certificate from the Principal / Headmaster / District Educational Officer / Chief Educational Officer / District Adi Dravidar Welfare Officer / Registrar / Controller of Examinations / Head / Director of the Educational Institution, Director / Joint Director of Technical Education /

Registrar of Universities as the case may be, in the prescribed format must be uploaded **at the time of submission of online application**, for each and every educational qualification up to the educational qualification prescribed **(As per Annexure Format I &II).**

- e) Failure to upload such documents at the time of submission of online application as evidence for 'Persons Studied in Tamil Medium' for all educational qualification up to the educational qualification prescribed, shall result in the rejection of candidature after due process.
- f) Documents uploaded at the time of submission of online application as proof of having studied in Tamil medium, for the partial duration of any course / private appearance at any examination, shall not be accepted and shall result in the rejection of candidature after due process.

(iii) Reservation for Persons with Disability:

The reservation of 4% for Differently abled will be followed as per G.O. (Ms.) No.20, Welfare of Differently Abled Persons (DAP.3.2) Department, dated 20.06.2018.

Note : The reservation of 4 % of A & B category post should be filled by persons with disabilities.

As per G.O (Ms.) No. 50, School Education (E.E-1 (1)) Department, Dated. 25.02.2016.

(i) The Tamil Nadu Governor in exercise with the power conferred to him, as per the section 33 for the persons with disabilities (equal opportunities, protection of rights and full participation) Act, 1995, ordered that while appointing the differently abled persons for direct recruitment for appointment to the post of Block Educational Officer, in the Special Rules for the Tamil Nadu Elementary Educational Subordinate Service shall be filled only with the disabled persons, who have One-Leg or One-hand and excluding the other categories.

List of posts identified under Group B categories suitable for Differently abled Persons:

As per G.O (Ms.) No. 09, Welfare of Differently Abled Persons (DAP-3.2) Department, Dated. 15.07.2020.

- (i) The following categories of disabilities to be accommodated for the post of Block Education Officer.
 - HH Hard of hearing
 - LD Loco Motor Disability (OA-One Arm and OL One Leg)
 - LC Leprosy cured
 - DF Dwarfism
 - AC Acid attack Victims
 - MD– Multiple Disability (Except for those multiple disabilities which are individually excluded)

Note;

As per Sections 26 and 27 (c) of the Tamil Nadu Government Servants (Conditions of Service) Act, 2016, reservation of appointment to "Destitute Widows" and "Ex-Servicemen" will not be applicable to this recruitment.

Determination of the Community for Transgender:

- (i) The Transgender candidates, who do not possess any community certificate, may choose to be considered under Most Backward Classes as per G.O.(Ms.) No.28, Backward Classes, Most Backward Classes and Minorities Welfare Department, dated 06.04.2015.
- (ii) The Transgender candidates who belong to Scheduled Castes/ Scheduled Castes (A) / Scheduled Tribes communities and possess community certificate as such, shall be considered as per their respective community.
- (iii) The Transgender candidates who belong to the communities other than Scheduled Castes/ Scheduled Castes (A) / Scheduled Tribes and possess community certificate as such are permitted to choose to be considered as belonging to their own community or as Most Backward Classes whichever is advantageous to them, at the time of Online Registration itself. Once the individual opts to be considered as a particular community, it shall be crystallized and this option shall not be changed in future.

Reservation in Employment for Transgender: -

[Refer G.O.(Ms.)No.90, Social Welfare and Nutritious Meal Programme [SW8(2)] Department, dated 22.12.2017]

- (i) The Transgender candidates who identify themselves as 'Female' shall be considered against both 30% reservation for women as well as 70% reservation for the General Category (both Men & Women).
- (ii) The Transgender candidates, who identify themselves as 'Male' or 'Transgender', shall be considered against the 70 % reservation for General Category (both Men & Women).
- (iii) The above concessions shall be granted subject to production of certificate identifying them as Transgender or Transgender 'Male' or Transgender 'Female', as the case may be, issued by the Tamil Nadu Transgender Welfare Board (TNTGWB).

4. QUALIFICATIONS:

A. Age Limit (as on 01.07.2023)::

Notwithstanding anything contained in sub-section (8) of section 20 of the T.N. Government Servants (Conditions of Services) Act, 2016, no person shall be eligible for appointment by direct recruitment to any of the categories specified in these rules, if he / she has completed **40 years of age**, on the first July 2023.

Provided that for direct recruitment to any of the categories specified in these rules, the age limit prescribed above shall be increased by **five years** in respect of candidates belonging to Backward Classes, Backward Class Muslims, Most Backward Classes or Denotified Communities, Scheduled Castes, Scheduled Tribes and Destitute widows of all castes.

As per Part III – Section 1(b), Special Rules for the Tamil Nadu Elementary Education Subordinate Service, Section 48-A Rule 6 (a) T.N. Government Gazette No.36, Date. 30.01.2020 and [G.O.(Ms). No.12, School Education, EE1(1), 30.01.2020].

Explanation:

Notwithstanding anything contained in the Act or in the Special Rules for the various State and Subordinate Services, a differently abled person shall be eligible for age concession up to ten years over and above the age limits prescribed for appointment to the post by direct recruitment only, provided the applicant is otherwise fully suitable and the handicap is not such as would render him incapable of efficiently discharging the duties of the post for which he is selected.

As per section 64 of Tamil Nadu Government Servants (Conditions of Service) Act, 2016.

B. Educational Qualifications (As on the date of Notification):

No person shall be eligible for appointment to the service to the post of Block Educational Officer, unless he possesses the minimum qualifications as follows:

(i) A degree of any University recognized by University Grant Commission or its equivalent and B.Ed. Degree in any University recognized by University Grant Commission or its equivalent. Provided that a degree should be from any one of the subjects such as Tamil, English, Mathematics, Physics, Chemistry, Botany, Zoology, Biology, Geography and History.

As per Part III – Section 1(b), Special Rules for the Tamil Nadu Elementary Education Subordinate Service, Section 48-A Annexure (Referred to in Rule 6 (b) (i)) T.N. Government Gazette No.36, Date.30.01.2020 and [G.O.(Ms). No.12, School Education, EE1(1), 30.01.2020]

(ii) The candidates not having prescribed educational qualifications, as on the date of notification shall not be eligible to apply. The candidates should satisfy themselves about their eligibility criteria before applying. It is to be noted that if a candidate is allowed to appear for the examination, it does not mean that the eligibility of the candidate is verified. The eligibility of the candidate shall be verified by the Board only at the time of Certificate Verification (if called for).

C. Equivalence of Qualification: Candidates claiming equivalence of qualification to the prescribed qualification should upload and submit evidence for equivalence of qualification in the form of Government Order. Those who have applied for their equivalence Government Orders should submit their equivalence order at the time of Certificate Verification, failing which, their candidature will be summarily rejected after due process.

(For further details regarding equivalence of qualification refer Annexure – IV of this Notification and also refer note under para. 9 of the "Instructions to the Candidates") (<u>http://www.trb.tn.gov.in)</u>.

D. Qualification Criteria:

- (i) Candidates who obtained a Degree after undergoing a course of one year duration (Double degree /Dual degree etc.) are not eligible to apply for this recruitment.
- (ii) Candidates who obtained any of the required qualifications (SSLC, HSC, U.G. Degree and B.Ed., degree) simultaneously are not eligible to apply for this recruitment.
- (iii) In cases where the Special Rules prescribe a Diploma or a Degree or a Post Graduate Degree as a qualification for appointment, then; -
 - (a) a diploma obtained, after completion of S.S.L.C. or Higher Secondary Course [10+3 (3 Years Diploma)] or [10+2+2 (Lateral Entry)]; or
 - (b) a degree obtained, after completion of S.S.L.C. and Higher Secondary Course (10+2+3 or more)

As per Explanation-I of Section 25 of the Tamil Nadu Government Servants (Conditions of Service) Act, 2016.

The candidates must have obtained Graduation with Bachelor of Education after completion of S.S.L.C., Higher Secondary Course or its

equivalent, (10+2+3+1) or (10+2+3+2) or (10+2or3+3+1) or (10+2or3+3+2) pattern from any University or Institution recognized by the University Grants Commission.

(iv) The Candidates not having prescribed qualifications, as on the date of notification shall not be eligible to apply for the examination. The candidates should satisfy themselves about their eligibility criteria before applying. All qualifying certificates including PSTM Certificate should have been obtained on or before the last date for submission of filled in online application announced in the recruitment notification.

E. Adequate knowledge of the official language of the State, namely, Tamil:

(i) No person shall be eligible for appointment to any service by direct recruitment unless he has adequate knowledge of official language of the State, namely, Tamil:

Provided that a person, being otherwise qualified for appointment to the post to which recruitment is to be made, may apply for recruitment to the post, despite the fact that, at the time of such application, he does not possess an adequate knowledge of Tamil. If selected and appointed, such a candidate should pass the Second-Class Language Test (Full Test) in Tamil conducted by the Tamil Nadu Public Service Commission, within a period of two years from the date of appointment failing which he will be discharged from service.

As per section 21 (1) of the Tamil Nadu Government Servant (Conditions of Service) Act, 2016.

Note: Candidates should possess adequate knowledge in Tamil. (For further details refer para 10 of "Instructions to the candidates") (<u>http://www.trb.tn.gov.in)</u>

(ii) Compulsory Tamil language paper for recruitment : -

Notwithstanding anything contained in section 21, on and from the 1st day of December 2021, any person who applies for recruitment to any post in any service by direct recruitment shall pass the Tamil language paper in the examination conducted for the recruitment with not less than forty percent marks.

As per Tamil Nadu Government Gazette No.20, Part IV – Section 1 Dated.13.01.2023 and section 21-A of Tamil Nadu Government Servant (Conditions of Service) Act, 2016.

5. HOW TO APPLY:

- a) Read carefully the "How to Apply" section given in the advertisement / website.
- b) Candidates should apply only through online mode in the Teachers Recruitment Board website: <u>https://www.trb.tn.gov.in</u>. The application process is entirely online. No other mode of application will be entertained.
 - c) A Valid e-mail id and Mobile Number of candidates are mandatory for registration and e-mail id should be kept active for any future correspondence.
 - d) Evidence for claims made by the candidate, while applying in online shall be uploaded by the candidate at the time of Registration itself. The same will be verified subsequently at the time of Certificate Verification.
 - e) All the particulars and documents mentioned in the online application including name of the candidate, post applied for, subject applied for, communal reservation, date of birth, address and all other fields will be considered as final and no modifications will be allowed after the last date specified for applying through online. Since certain fields are mandatory and fixed which cannot be edited, candidates are requested to fill in the online application form with utmost care and caution, as no correspondence regarding change of those particulars will be entertained at any cost.

- f) Incomplete or defective applications shall be summarily rejected. No representation or correspondence regarding such rejection shall be entertained under any circumstances.
- g) The candidates are advised to exercise due diligence at the time of filling the application. In case, if duplicate application of a candidate for the same subject is detected, Board will consider only the latest application.

6. UPLOADING THE DOCUMENTS:

Applicants should upload the required documents for proof in respect of all the claims made in the application with reference to this notification at the time of submission of online application itself. If the required following certificates are not uploaded by the applicant, while applying, his / her application will be rejected after due process.

A. Qualification Certificates:

The following Original Certificates and Mark Statements to be uploaded in the portal along with the Online application:

- (i) 10th/ SSLC.
- (ii) 12th/ Higher Secondary / Diploma or its equivalent.
- (iii) U.G. Degree in the relevant subject or its equivalent
 - 1. Consolidated Marksheet of all Semester.
 - 2. Degree Certificate or Provisional Certificate
- (iv) B.Ed., Degree or its equivalent.
 - 1. Consolidated Marksheet of all Semester
 - 2. Degree Certificate or Provisional Certificate
- (v) Certificate from the last studied Institution.
- (vi) Character Certificate from a Gazetted officer or from any responsible person.

B. Community Certificate:

Community Certificate should be obtained from the following authorities of Government of Tamil Nadu for candidates claiming Communal reservation as the case may be. (i) ST - Revenue Divisional Officer (if the certificate is issued after 11.11.1989)

(ii) SC/SCA – Tahsildar of native taluk of the candidate.

- (iii) BC, BCM and MBC / DNC Headquarters Deputy Tahsildar or Special Deputy Tahsildar.
- (iv) Community Certificate of married woman issued with father's name alone (Not with Husband's Name) shall be accepted.
- (v) Community certificates issued by any other State or Union Territory Authorities will not be considered against vacancies reserved for 69% communal reservation. They will be considered only under Other Category (OC).

C. Tamil Medium Study Certificate:

For the post of Block Educational Officer, candidate who claims reservation under PSTM (Persons Studied in Tamil Medium) category has to submit Tamil Medium Study Certificate in the prescribed format (**ANNEXURE I** & II).

As per G.O.(Ms.) No.82, Human Resource Management (S) Department, Dated 16.08.2021.

D. Disability Certificate:

A candidate who wants to avail the benefit of reservation under PWD candidates would have to submit an Identity Card and Passbook with Disability Certificate issued by the Competent Authority.

E. No Objection Certificate: (N.O.C.)

Persons who are in the service of the Indian Union or a State in India or in the employment of Local Bodies or Universities, or Quasi Government Organizations constituted under the authority of the Government of India or of a State in India whether in regular service or in a temporary service need not send their application through their Head of Department or Employer. Instead, they may directly apply to the Teachers Recruitment Board after duly informing their Employer in writing that they are applying for the particular recruitment and with the condition that they should produce "No Objection Certificate" in the form prescribed as in Annexure III, from an authority not below an Officer / Division Head at the time of attending the Certificate Verification.

Note :

- (i) Persons who get employment after the submission of their applications and before the receipt of intimation admitting them to the Certificate Verification / requiring produce original documents for verification should also produce the "No Objection Certificate".
- (ii) In case any Criminal / Disciplinary action is taken against any persons or if any punishment is imposed against such persons after the production of "No Objection Certificate" and before the actual appointment, such applicants should report this fact forthwith to the Teachers Recruitment Board indicating their Register Number. Any violation or failure to comply with these instructions will end in rejection of candidature.
- (iii) "Others" i.e. Applicants not belonging to SCs, SCAs, STs, MBCs/DNCs,BC and BCMs who have put in five years and more of service in the State are not eligible as per Section 3(r) and Section 20(8) of Tamil Nadu Government Servants (Conditions of Service) Act, 2016.

7. EXAMINATION FEE

- a) The Examination fee is Rs.600/- for all the candidates except SC, SCA, ST and differently abled persons. For SC, SCA, ST and differently abled persons the examination fee is Rs. 300/- Since the examination fee is different for various categories, candidates are advised to enter the correct Community / Person with Disability category. Once the payment is made, it will not be refunded.
- b) SMS alert regarding successful Payment will be sent to the registered mobile phone of the candidate.
- c) Online payment to be made only through Payment Gateway.
 (Net banking/Credit Card / Debit Card)

- d) Offline mode of payment in any form such as Demand Draft / Postal order, etc. will not be accepted.
- e) The candidates should also to pay the service charges as applicable for online payment.
- f) Failure to pay the prescribed fee in time, along with the online application, will result in the rejection of application after due process.
- g) Fee once remitted shall not be refunded or adjusted for future test under any circumstances.
- h) If a candidate pay the fee for more than one time, the amount will not be refunded.

8. SCHEME OF EXAMINATION:

Part – A: Compulsory Tamil Language Eligibility Test: (Objective Type)

The Tamil Language Eligibility Test is a qualifying test and it will be conducted in objective type consisting of 30 questions for 50 marks and the duration of examination will be 30 minutes as part – A. This mark will not be considered for ranking.

- a. Syllabus for Tamil language eligibility examination is of class 10th standard level.
- b. Minimum 40% marks in part A examination (minimum qualifying marks) only to be eligible for the next level of evaluation of the main examination answer sheet.
- c. The procedure will be followed as mentioned in the G.O.(Ms) No. 49, Human Resources (M) Department, dated 23.05.2022 for exempting the differently abled candidates from the Compulsory Tamil Language eligibility test.

A. Compulsory Tamil Language Eligibility Test

The Tamil Language Eligibility Test is a qualifying test and will be conducted as per the scheme of examination mentioned above.

B. Written Examination:

- (i) The Date, Time and Centre for the OMR based Examination will be indicated in the Hall Ticket. The Hall Ticket for the eligible candidates will be uploaded by the Teachers Recruitment Board in its website. The candidates are advised to refer to the Teachers Recruitment Board website for details (http://www.trb.tn.gov.in). No written communication or the Hall Ticket will be sent to the candidates separately.
- (ii) The participation of the candidates in the OMR based Examination is purely provisional and does not confer any acceptance of their claim in the application.
- (iii) Scribes: Eligible Orthopedically Impaired candidates will be allowed assistance of scribes based on the Disability Certificate /Medical Certificate submitted by the candidates.
- (iv) Allotment of Centers: PWD candidates will be allocated within the district based on their communication address. Others will be allocated in any place since availability of centers are not uniformly spaced and numbers are limited.
- (v) Examination Results: The marks of written examination will be published in the website of Teachers Recruitment Board viz. <u>https://www.trb.tn.gov.in</u> and a press release will be issued in the visual media.

(vi) Resolution of Disputes related to Question paper, Answer key and Other Matters:

Through Objection Tracker, Teacher Recruitment Board would publish the tentative answer key on its website after the conduct of the examination. Any objections with regard to the key answer shall be submitted within the prescribed period after publication of the tentative answer key in the prescribed proforma available in the website. Through Objection Tracker, objections can be filed in dedicated link for a particular period only. Mail and written representations will not be entertained.

The objections received in the prescribed proforma, within due date will be referred to Subject Expert Committee for opinion and to take appropriate decision thereon by the Board. As per the decision of the Board, a revised and final answer key will be hosted in the website. No further objections on original key will be entertained.

The decision of the Board in this regard shall be final. Any objection filed after expiry of specified time, from the date of publication of tentative answer key/revised and final answer key would not be entertained. For deleted questions, if any, marks will not be awarded in the recruitment examinations.

Evidences for substantiating question wise Subject Expert Opinion like expert details, book details, page number, publisher etc., will not be provided since these are confidential details and in order to ensure secrecy of the question paper setting process.

B. Certificate Verification (C.V.):

The Board will prepare the list of Candidates for Certificate Verification (C.V.) in the ratio of 1:1.25 based on the OMR based Examination Marks only duly following the communal rotation and other relevant rules in vogue.

11. ACTION AGAINST CANDIDATES FOUND GUILTY OF MISCONDUCT:
