School Education – Tamil Nadu School Educational Subordinate Service – Identification of suitable post for the Differently Abled Persons under Group 'C' categories as per Section 32 of Persons with Disabilities (Equal Opportunities, Protection of Rights and Full Participation) Act, 1995 - Orders – Issued.

ORDER:-

In the letter first read above, the Director of School Education has stated that Teachers Recruitment Board (TRB) has requested for the category of Differently Abled Persons who are suitable for appointment in direct recruitment in certain posts of Special Teachers under the Special Rules for Tamil Nadu School Educational Subordinate Service, (viz.) Physical Education Teachers/Craft Instructor Grade-II (Sewing) / Music Teachers / Art Masters in Secondary and Training Schools. Teachers Recruitment Board has further requested the Government to issue Notification so as to exempt persons with certain disabilities as per provisions of Section 32 of the Persons with Disabilities (Equal Opportunities, Protection of Rights and Full Participation) Act, 1995 in respect of such posts of Special Teachers (i.e) Physical Education Teacher, Craft Instructor Grade-II (Sewing), Music Teachers and Art Masters in Secondary and Training Schools.

2. In the letter second read above, the State Commissioner for the Differently Abled has requested the Government to issue proper Notification under the provisions prescribed in section 33 of the Persons with Disabilities (Equal Opportunities, Protection of Rights and Full Participation) Act, 1995 for exempting certain categories of Differently Abled Persons from appointment in certain specified Special Teachers posts and also to issue necessary amendment to Rule 22 of the General Rules for Tamil Nadu State and Subordinate Services and proceed further with the process of recruitment.

3. In the Government Order third read above, orders have been issued identifying posts most suitable for the different categories of the Differently Abled Persons for 3% reservation in 'A' & 'B' Groups under section 32 of the Persons with Disabilities (Equal Opportunities, Protection of Rights and Full Participation) Act 1995. No separate orders have been issued duly identifying the Groups 'C' & 'D' categories of posts since all the posts in 'C' & 'D' categories are suitable for Differently Abled Persons.

4. The Government after careful examination of the proposal of the Director of School Education in consultation with Welfare of Differently Abled Persons and concerned departments have decided that the posts of Craft Instructor Grade-II (Sewing) Music Teacher and Art Masters in Secondary and Training Schools falling under Group 'C' are suitable only for the persons with specified disabilities, keeping in mind the physical requirements of the job.

5. Accordingly, in exercise of the powers conferred under clause (a) of section 32 of the Persons with Disabilities (Equal Opportunities, Protection of Rights and Full Participation) Act, 1995 (Central Act 1 of 1996.) the Governor of Tamil Nadu hereby identifies the posts specified in column (3) of the Table below as reserved for the persons with the disabilities specified in the corresponding entries in column (4) thereof.


